TABLE OF CONCORDANCE

This table identifies the primary sources for various provisions of the Draft Securities Act. For many provisions only the primary source from the Alberta *Securities Act* is identified, along with the comparable provisions from the Ontario *Securities Act* where the Ontario *Securities Act* is not the primary source but comparable provisions exist. Although not identified, many of these provisions are also substantially similar to comparable provisions in other provincial and territorial securities law statutes. While the substantive elements of the various provisions of the Draft Securities Act relate to the identified sources, those provisions may also have been redrafted to comply with federal statutory drafting conventions and norms and civil law harmonization.
